ABOUT AWI

The Animal Welfare Institute (AWI) is a nonprofit organization founded in 1951 whose mission is to alleviate the suffering caused to animals by people. We seek better treatment of animals everywhere—in the wild, in research, in agriculture, in commerce, and in our communities. AWI employs more than 30 staff and consultants located in our headquarters in Washington, DC, and remotely across the United States. AWI is program oriented—more than 90 percent of our budget goes to support our programs to protect terrestrial and marine wildlife, farmed animals, animals in research, and companion animals. We advance our mission through strategically crafted political and legal advocacy, educational programs, litigation, research, and engagement with industry, policymakers, scientists, and other NGOs. AWI is committed to fostering diversity, equity, and inclusion in our culture, policies, and practices.

POSITION SUMMARY

We seek a full-time scientist or senior scientist to join our Terrestrial Wildlife Program team (Program). This is a new role that expands our Program and presents an exciting opportunity to enhance our existing scientific expertise and develop and implement innovative legal, policy, and administrative efforts to protect terrestrial wildlife at local, state, national, and international levels. You will use scientific principles and evidence to advance the Program's mission to reduce the detrimental impacts of human activities on wild animals. Our efforts include working to foster humane, nonlethal, science-based solutions to conflicts with wildlife, protect threatened and endangered species and their habitat, and address unsustainable and inhumane global wildlife trade. You will report to the Program's Director and Senior Attorney, and work with the Program's attorney, other scientist, and policy advisors as an integral part of an experienced, close-knit, and collaborative team.

DUTIES AND RESPONSIBILITIES

- Identify and engage in opportunities to protect terrestrial wildlife through federal and state regulatory mechanisms, legislation, and litigation.
- Serve as an expert for Program activities on threatened and endangered species, human-wildlife conflict, and wildlife trade.
- Engage in administrative advocacy by drafting petitions for rulemaking, comments on proposed regulations, and ESA listing petitions.
- Conduct scientific literature reviews, analyze published scientific studies and trade data, and identify and assess scientific issues to support Program activities.
- Further the Program's work related to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).

- Research and prepare reports, white papers, and other technical analyses to engage in public education and outreach and to influence public policy.
- Support complex litigation by participating in issue identification, factual investigation, other pre-litigation work, and coordinating expert reports and testimony.
- Advance AWI's legislative efforts by engaging with state and federal policymakers, and providing expert testimony before the US Congress, state legislatures, and administrative agencies.
- Assist with the review of applications for AWI's Christine Stevens Wildlife Awards.
- Represent AWI at meetings, hearings, conferences, and other events.
- Draft action alerts, press releases, op-eds, educational materials, social media posts, website content, donor updates, and AWI Quarterly magazine articles highlighting the Program's activities.
- In conjunction with AWI's communications staff, devise and implement appropriate media strategies for the Program's activities.
- Cultivate strong relationships and communicate with government officials, scientists, and advocates within coalitions and at other NGOs.

REQUIREMENTS

- An advanced degree in conservation biology, wildlife biology, ecology or a related field is strongly preferred. We are willing to consider candidates with a bachelor's degree in one of these fields when combined with significant relevant experience.
- A minimum of three years of relevant experience is preferred for the scientist position, and a minimum of ten years of relevant experience is preferred for the senior scientist position. We are willing to consider candidates with exceptional potential and alignment with AWI's mission but with a varied duration of professional experience.

QUALIFICATIONS AND SKILLS

We seek candidates with the following preferred qualifications, noting that we desire applicants with diverse lived experiences. We are willing to consider candidates with equivalent or alternative professional and personal qualifications.

- Passion for AWI's mission and demonstrated commitment to public interest work, including the prevention of animal suffering and the preservation of wildlife.
- Experience using a broad suite of advocacy tools, including federal and state administrative rulemakings and petitions, legislation, and litigation.
- Experience analyzing complex scientific and technical documents and researching, synthesizing, and presenting scientific information to a wide range of audiences.
- Participation in some tasks involved in complex litigation, including factual investigation, other pre-litigation work, and coordination of expert reports and testimony.
- Experience working across disciplines using law, science, policy, and communications to advance science-based advocacy.
- Exceptional research, writing, and communication skills.
- Excellent oral advocacy skills, including public speaking experience.
- Working knowledge of the Endangered Species Act, National Environmental Policy Act, Administrative Procedures Act, and other federal & state laws that protect terrestrial wildlife.
- Knowledge of CITES issues and processes.
- Exceptional ability to facilitate conversation and drive decision-making in a consensus-oriented team and organization.
- Demonstrated ability to take initiative and think creatively about Program activities and strategies.
- Demonstrated ability to cultivate and maintain relationships with a wide range of stakeholders and policymakers, including other NGOs, state and federal government officials, and legislators and their staff.
- Superb work ethic and sound judgment, with the ability to assume responsibility for project leadership, including planning and implementation, and ability to balance independent action with regular communication with Director and Program team members.

- Demonstrated ability to work independently and proactively, as well as high capacity to work constructively in a team environment.
- Demonstrated ability to work under pressure in a fast-paced environment, meet internal and external deadlines, use good time management and organizational skills, and prioritize a heavy workload.
- Commitment to the highest standards of professional conduct.
- Strong attention to detail, as well as problem-solving skills.
- Proficiency in Microsoft Word, Excel, PowerPoint, and statistical modelling software.
- Ability to work effectively with and to understand the needs and concerns of individuals from diverse cultures, backgrounds, and orientations.
- Commitment and positive contribution to the creation of a diverse, equitable, and inclusive work culture that celebrates differences and where everyone feels like they belong.

JOB LOCATION

The position may be located either on-site at AWI's headquarters in Washington, DC, or in a remote location anywhere in the United States.

The starting salary range is \$70,000-\$110,000. Salary is based on education, experience, qualifications, skills, internal equity, and location. The maximum of the hiring range is reserved for candidates with the highest qualifications and relevant experience.
