Sec. 2.31: Institutional Animal Care and Use Committee (IACUC)

(c) IACUC functions. With respect to activities involving animals, the IACUC, as an agent of the research facility, shall:

(7) Review and approve, require modifications in (to secure approval), or withhold approval of proposed significant changes regarding the care and use of animals in ongoing activities.

According to the IACUC approved protocol for the collection of whole blood in goats "Animals are inoculated subcutaneously over the rib cage." Eleven goats were observed to have numerous circular raised lesions approximately two to five centimeters in diameter over their shoulders that were consistent with inoculation site reactions. According to the attending veterinarian he had recently noticed the shoulder lesions. He stated that he had examined some of the goats and determined that the lesions were consistent with injection site reactions.

Failure to place the inoculations in the proper anatomical site constitutes an unapproved significant change to the approved protocol. A system should be in place to ensure that proposed significant changes to activities involving the care and use of animals are reviewed and approved by the IACUC prior to their implementation.
